ORDINANCE NO. 1606

**AN ORDINANCE REQUIRING THE PLACEMENT  
OF YIELD SIGNS WITHIN THE  
VILLAGE OF CHANNAHON,  
WILL AND GRUNDY COUNTIES, STATE OF ILLINOIS**

**WHEREAS**, within the Village of Channahon certain conditions exist at intersections which pose a risk to the health, safety and welfare of the community; and

**WHEREAS**, there are intersections within the Village where application of the normal right-of-way rule is unduly hazardous given the traffic flow and the likelihood of pedestrian activity; and

**WHEREAS**, the Board of Trustees is authorized by Chapter 625, Section 5/11-302 of the Illinois Compiled Statutes to place traffic control devices upon highways within the corporate boundaries; and

**WHEREAS**, the Board of Trustees of the Village of Channahon has determined that it is in the best interest of the Village to place traffic control signs at certain locations in order to prevent imminent injury or damage to persons and property.

**NOW, THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHANNAHON, WILL AND GRUNDY COUNTIES, STATE OF ILLINOIS, AS FOLLOWS:**

**SECTION 1:** That the following is hereby deleted from Ordinance Number 1596:

1. Northbound Rivers Plaza Drive at Red Wing Lane
2. Southbound Rivers Plaza Drive at Red Wing Lane

**SECTION 2:** That the Public Works Department of the Village of Channahon is directed to place and maintain yield signs which conform to the Illinois Manual on Uniform Traffic Control Devices for Streets and Highways at the following intersections:

1. Westbound Red Wing Lane at Rivers Plaza Drive
2. Eastbound Red Wing Lane at Rivers Plaza Drive


**SECTION 3. SEVERABILITY:** This Ordinance and every provision thereof, shall be considered severable. In the event that any court of competent jurisdiction may find and declare any word, phrase, clause, sentence, paragraph, provision or section or part of a phrase, clause, sentence, paragraph, provision or section of this Ordinance is void or unconstitutional, the remaining words, phrases, clauses, sentences, paragraphs and provisions and parts of phrases, clauses, sentences, paragraphs,

provisions and sections not ruled void or unconstitutional shall continue in full force and effect.


**SECTION 4. REPEALER:** All ordinances or parts of Ordinances in conflict with any of the provisions of this ordinance shall be, and the same are hereby repealed.

**SECTION 5. EFFECTIVE DATE:** That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.

PASSED this 21<sup>st</sup> day of December, 2009, with 5 trustees voting aye, 0 trustees voting nay, 0 trustees abstaining, and with 1 trustee absent, the President not voting: said vote being: MCMILLIN aye, SLOCUM absent, GRECO aye, MILITELLO aye, PAPESH, aye, NASH aye, and COOK aye voting.
