ORDINANCE NO. 1611

**AN ORDINANCE AMENDING THE VILLAGE OF
CHANNAHON CODE OF ORDINANCES WITH
RESPECT TO COMPLIANCE TICKETS**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES
OF THE VILLAGE OF CHANNAHON WILL AND GRUNDY COUNTIES,
ILLINOIS IN THE EXERCISE OF ITS HOME RULE AND OTHER POWERS AS
FOLLOWS:**

Section 1. Amendment.

That 10.98(F)(1) be and the same is hereby amended by deleting the following:

Possession, sale and use of fireworks (§13.5/35-2) \$100

Public intoxication (§13.5/800-4) \$200

Possession of cannabis; not more than 2.5 grams (§131.550/4(A)) \$100

And adding the following:

Unless listed above, violations under Title 13, Chapters 13.5
Misdemeanors \$100.00

Unless listed above, violations under Title 13, Chapter 131 Drug and
Related Offenses \$100.00

Unless listed above, violations under Title 13, Chapter 132 Gambling
Offenses \$100.00

Section 2. Severability. If any section, paragraph, clause or provision of this Ordinance is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.


Section 3. Repealer. All ordinances, resolutions, orders or parts thereof, which conflict with the provisions of this Ordinance, is to the extent of such conflict, hereby repealed.

Section 4. Effective Date. This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form.

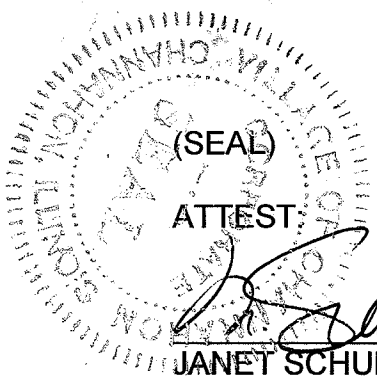
