ORDINANCE NO. 1615

AN ORDINANCE AMENDING TITLE V, "PUBLIC WORKS" CHAPTER 52, "WATER" OF THE VILLAGE OF CHANNAHON CODE OF ORDINANCES

BE IT ORDAINED IN THE EXERCISE OF ITS HOME RULE AND OTHER POWERS BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHANNAHON, WILL AND GRUNDY COUNTIES, ILLINOIS:

SECTION 1: That Title V, Chapter 52, Section 52.14, Paragraph G, of the Village of Channahon Code be and the same is hereby deleted in its entirety and the following inserted in lieu thereof:

(G) Service charge (per month per meter):

SECTION 2. That Title V, Chapter 52, Section 52.14, Paragraph H, of the Village of Channahon Code be and the same is hereby deleted in its entirety.

SECTION 3. SEVERABILITY: Each Section and part thereof this ordinance is deemed to be severable and should any section or part thereof be held invalid or unconstitutional by any court of competent jurisdiction, such ruling shall not affect the validity or constitutionality of the remaining portions of this ordinance.


SECTION 4. REPEAL OF INCONSISTENT ORDINANCES: All ordinances or parts thereof in conflict with the terms of this ordinance are hereby repealed and of no further force and effect to the extent of such conflict.

SECTION 5. EFFECTIVE DATE: That this Ordinance shall be in full force and effect on May 1, 2010 after its passage, approval and publication in pamphlet form as provided by law.


