ORDINANCE NO. 1652

AN ORDINANCE AUTHORIZING THE
EXTENSION OF AN EMPLOYMENT AGREEMENT

WHEREAS, it is in the best interest of the Village of Channahon to extend the Employment Agreement of Ignacio Pena.

NOW THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Village of Channahon, Will and Grundy Counties, Illinois as follows:

SECTION 1. AUTHORIZATION. The Village President be and is hereby authorized and directed to execute the Extension Agreement attached hereto as Exhibit A and the Village Clerk is authorized and directed to attest to said signature.

SECTION 2. SEVERABILITY. If any section, paragraph, clause or provision of this Ordinance is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

SECTION 3. REPEALER. All ordinances, resolutions, orders or parts thereof, which conflict with the provisions of this Ordinance, is to the extent of such conflict, hereby repealed.

SECTION 4. EFFECTIVE DATE. This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form.

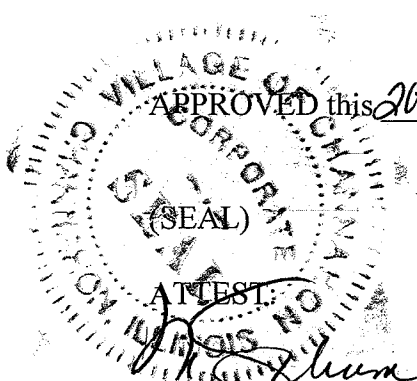
