## **RIBBON CUTTING OF THE NEW CHANNAHON COMMUNITY ELECTRONIC MESSAGE SIGN**

On Wednesday, October 21, 2015 at 5:00 p.m. Village President, Missey Moorman Schumacher and Little Miss Channahon, Addison Lowman led the Village of Channahon and Board of Trustees, Channahon Park District, Channahon Economic Development Corporation, People for Channahon Parks Foundation, and the Three Rivers Festival Committee in the cutting of the ribbon for the new Channahon Community Electronic Message Sign.

Village President, Missey Moorman Schumacher stated, "This sign is the product of a collective community vision and the wonderful collaborative relationship enjoyed by all of the groups involved in making it happen. We are fortunate to have so many people working cooperatively toward a common goal."

The electronic sign is located on the northeast corner of Eames Street and Navajo Drive and is jointly owned by the Village of Channahon and the Channahon Park District. "It was great to be a part of the team of local government and not for profit partners that brought this new informational sign to the community. The unique design stands out from other cities and villages and supports the heritage of the area, representing an I&M Canal lock door. Whether people are passing through Channahon or live here, it's a great way to inform everyone of what the great things we all have to offer," said Executive Director, Channahon Park District, Chuck Szoke.

Displays on the Channahon Community Electronic Message Sign are available to governmental groups and not for profit organizations that provide programs and services of interest to the general public within the Village of Channahon and the Channahon Park District.
